On 31 January 2018, the Purchaser, the Vendor and the Guarantors entered into the Agreement, pursuant to which the Purchaser has conditionally agreed to acquire for and the Vendor has conditionally agreed to dispose of the Sale Shares. On 24 October 2018, the Purchaser, the Vendor and the Guarantors entered into the Supplemental Agreement to amend certain terms and conditions of the Agreement, in which the Consideration of HK\$692,000,000 shall be payable by the Purchaser in the following manner: (i) HK\$210,000,000 shall be settled by way of cash; (ii) HK\$133,920,000 shall be settled by the issue of 48,000,000 Consideration Shares at the Issue Price of HK\$2.79 per Consideration Share by the Company to the Vendor; and (iii) HK\$348,080,000 shall be settled by the issue of the Promissory Note with principal amount of HK\$348,080,000 by the Company to the Vendor.
